1. The undersigned organization, the invited unit, agrees to comply with all the provisions prescribed by the Shrewsbury Street Italian Heritage Parade Committee as published in the Parade Committee's Standards and Regulations (Please refer to enclosures and our website [www.shrewsburystitalianheritageparade.com](http://www.shrewsburystitalianheritageparade.com)) for a printed copy of the parade rules and regulations.
2. The undersigned organization understands that:
  - (a) This invitation is conditioned on the undersigned organization's express agreement to comply with the Parade Committee's Standards and Regulations.
  - (b) This invitation does not imply an invitation to any future parade;
  - (c) The deadline for acceptance of this invitation is printed above and if this participation agreement is not signed and returned by the deadline date it will indicate that the organization does not wish to participate and the organization's place in the Parade will be assigned to an additional invitee unit.
3. The undersigned organization understands that a unit will not be allowed to participate in the Parade unless a signed participation agreement has been returned to the Parade Committee by the deadline date.
  - (a) If applicable under the Parade Committee's Standards and Regulations, the undersigned organization has submitted to the Parade Committee prior to signing this Agreement or with this Agreement the names of individuals in the unit or a photograph of the unit's drill vehicles.
  - (b) The undersigned organization agrees to march and perform with the number of members noted below.
4. The participating organization recognizes that the Parade Committee, Parade Chairman, and on the day of the Parade, the Operations Chairman, has full and exclusive authority to interpret, determine compliance with, and take action to enforce the Parade Committee's Standards and Regulations and the participating organization agrees to abide by and cooperate with the implementation of any such ruling subject only to subsequent written appeal to the Parade committee's Executive Board.
5. The participating organization, for itself and on behalf of its members/employees and other individuals who may participate in the parade as part of its organization, in consideration of any support that may accompany that participation, agrees.
  - (a) not to sue or assert a claim against the Shrewsbury Street Italian Heritage Parade Committee or any of its members on account of any occurrences on the day of the Parade or prior to the day of the Parade if in connection with Parade activity, and
  - (b) Agrees to indemnify and hold harmless the Shrewsbury Street Italian Heritage Parade Committee and its individual members from and against any and all actions, claims, damages, injuries, losses, penalties of every name and nature whatsoever arising from or in connection with the participating organization's participation, or in the preparation for participation in, the Parade.
  - (c) Liability & Insurance-If your organization has liability insurance, the Shrewsbury Street Italian Heritage parade Committee, requests that you refer to item IX in the Parade Standards & Regulations and provide a certificate of insurances as outlined.
6. Refer to section 3.10 in the Parade Standards and Regulations: The right is reserved to remove any participating unit from the line of March at any time for safety reasons, indecorous behavior or noncompliance with the Participation Agreement.
7. Refer to section IV 4.2 in the Parade Standards and Regulations: There is no drinking of alcoholic beverages or unlawful use of controlled or illegal substances in the staging area or in the line of March. Violators will be immediately evicted from the Parade and their unit will be subject to being banned from the Parade and future participation.
